2. Date, Venue, Timing and Centre details will be available in the Admission Letter. No hard copy of admission letter will be sent to any candidate by post.
3. Since examination will be conducted in multiple shifts using multiple question sets, Normalization methodology for Computer Based Test Exams shall be adopted by the Commission to convert raw score into Normalized score. "Extract of Normalization methodology is available in OSSSC web portal for reference of candidates".
4. PwD candidates having benchmark disability shall be allowed compensatory time of 30 minutes (@20 minutes per hour) as per rules.
5. It is reiterated that as provided under para 10 of the advertisement the Preliminary Examination is meant to serve as a screening test only.

All other terms and conditions of the Advertisement published shall remain unaltered.
